ORDINANCE NO. 15-2022

AN ORDINANCE AMENDING CHAPTER 24, WATER, SEWERS AND SEWAGE DISPOSAL, ARTICLE III, SEWERS AND SEWAGE DISPOSAL, BY CHANGING SEC. 24-250, SEWER BACK-UP PREVENTION PROGRAM, OF THE MUNICIPAL CODE OF THE VILLAGE OF EVERGREEN PARK

BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Evergreen Park, Cook County, Illinois, as follows:

Section 1

That Chapter 24, Water, Sewers and Sewage Disposal, Article III, Sewers and Sewage Disposal, be amended by changing Sec. 24-250(b)(2) to read as follows:

Sec. 24-250 Sewer Back-Up Prevention Program.

...

(b) Terms and conditions of the program.

...

(2) The maximum reimbursement for the initial installation of an overhead sewer shall be 50% of the actual cost or \$5,000.00, whichever is less, provided that the Board of Trustees may change the maximum amount by motion in the future.

...

Section 2

This ordinance was passed pursuant to the home rule powers of the Village of Evergreen Park.

Section 3

If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this ordinance.

Section 4

All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed insofar as they conflict herewith.

Section 5

This ordinance shall be immediately in full force and effect after passage, approval and publication. This ordinance is authorized to be published in pamphlet form.
