

ORDINANCE NO. 26-2022

**AN ORDINANCE OF THE VILLAGE OF EVERGREEN PARK,
COOK COUNTY, ILLINOIS, APPROVING A FIRST AMENDMENT
TO MUNICIPAL RECYCLING AND WASTE AGREEMENT
WHICH EXTENDS THE CURRENT AGREEMENT WITH WASTE
MANAGEMENT OF ILLINOIS, INC. FOR ONE YEAR UNTIL
DECEMBER 31, 2023**

BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Evergreen Park, Cook County, Illinois, as follows:

Section 1

That the First Amendment to Municipal Recycling and Waste Agreement with Waste Management of Illinois, Inc., in substantially the form attached hereto, is hereby approved for and on behalf of the Village. The Mayor is hereby authorized to execute the same for and on behalf of the Village.

Section 2

All statutes of the State of Illinois or any parts thereof which are in conflict with the provisions of this ordinance are hereby superseded by this ordinance enacted under the home rule power of the Village of Evergreen Park.

Section 3

This ordinance shall be immediately in full force and effect after passage and approval.

**FIRST AMENDMENT TO
MUNICIPAL RECYCLING AND WASTE AGREEMENT**

This First Amendment to the Municipal Recycling and Waste Agreement (the "First Amendment") is entered into on December 5 __, 2022 by and between Waste Management of Illinois, Inc. ("WM") and the Village of Evergreen Park ("Village").

Recitals

- A. Village and WM entered into a Municipal Recycling and Waste Agreement on or about January 1, 2018 (the "Agreement"); and,
- B. The Agreement is set to expire on December 31, 2022 and the Village and WM desire to extend the term of the Agreement, as further discussed below.

Agreement

Effective January 1, 2023, the parties agree to amend the Agreement in the following manner:

- 1) The term of the Agreement shall be extended for one additional year, through December 31, 2023. Thereafter, this Agreement may only be extended by an amendment signed by both parties.
- 2) In Section V.a of the Agreement, the monthly rate per Residential Unit for collection of Acceptable Waste and Recyclables shall increase to \$27.49.
- 3) In Section V.a and Exhibit B, Section G of the Agreement, the monthly fee per Residential Unit for At Your Door Special Collection shall increase to \$1.51.
- 4) Except as modified herein, the terms and conditions of the Agreement shall continue in full force and effect.

The parties have caused this First Amendment to be executed by their duly authorized representatives effective as of the day and year first above written.
