### ORDINANCE NO. 22-2015

AN ORDINANCE AMENDING SECTION 3-56, SECTION 3-58, AND SECTION 3-36 OF CHAPTER 3, ALCOHOLIC LIQUOR, OF THE EVERGREEN PARK MUNICIPAL CODE BY ADDING CLASS P LIQUOR LICENSES

BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Evergreen Park, Cook County, Illinois, as follows:

#### Section 1

That Section 3-56, License classifications, of Chapter 3, Alcoholic Liquor, of the Evergreen Park Municipal Code be amended to read as follows:

#### Sec. 3-56. License classifications.

Licenses for sale at retail of alcoholic liquor shall be divided in the following classes:

- (6) Class ENT, entertainment. A Class ENT license may be issued in conjunction with a Class A, Class AA, Class B, Class D, Class E, Class EE, Class F, Class G, and Class P license under the terms and conditions established by the local liquor control commissioner. A Class ENT license entitles a licensee to provide entertainment under the terms and conditions of the license.
- (12) Class P, banquet party consumption on premises. A Class P license entitles the licensee to make sales at retail of alcoholic liquors for consumption only on the premises during times when a party or banquet is being conducted, and then only to invited guests of the party or banquet. The sole business conducted on the premises shall be the provision of parties and banquets to private groups. Each party or banquet shall be evidenced by a written contract, which shall be maintained on the premises during the time of the party or banquet. There shall be no individual cover charge or other entrance charge collected from patrons. All sales of alcoholic liquor shall be made incidental to the service of food during the party and banquet. Food may be cooked on the premises or may be catered. No patrons of the premises shall smoke on any sidewalk, parkway, street, parking lot, or on any private property where they are visible to a residential dwelling unit. No sale or consumption of alcoholic liquor is allowed outside of the building.

### Section 2

That Section 3-58, Fees and limitations, of Chapter 3, Alcoholic Liquor, of the Evergreen Park Municipal Code be amended to read as follows:

#### Sec. 3-58. Fees and limitations.

(a) All licenses shall be on a calendar year basis. The license fee for each class of license and the maximum number of licenses in each class is as follows:

(b) The number of licenses authorized in this section for all classes shall remain at the number set forth in this section; provided, however, that any license in such classes which is revoked, or not used because of the termination of liquor business on the premises for which the license has been issued, shall automatically reduce the number of authorized licenses of the particular class by the total number of revoked or not used licenses in the particular class and shall reduce the total number of licenses available.

#### Section 3

That Section 3-36, Hours of operation, of Chapter 3, Alcoholic Liquor, of the Evergreen Park Municipal Code be amended to read as follows:

# Sec. 3-36. Hours of operation.

Licensed premises shall have the following hours of operation during which time alcoholic liquors may be sold, delivered, consumed or offered for sale:

(5) Class P shall be open only from 9:00 a.m. in the morning to 11:00 p.m. on all days, except Friday and Saturday when the closing hour shall be 12:00 midnight.

# Section 4

All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed insofar as they conflict herewith.

## Section 5

This ordinance shall be in full force and effect after passage and approval.
